Overview

As you may know, construction of the Annacis Island Wastewater Treatment Plant Outfall project is currently underway. This project is one of several upgrades Metro Vancouver is undertaking that will allow the plant to meet the needs of our growing population, strengthen its ability to operate in the event of an earthquake, adapt to climate change, and ensure the continued protection of public health and the environment.

The new outfall is expected to be in service by mid-2023; construction for the overall project is expected to be complete by summer 2024.

Hours of Work & Schedule

To complete work safely and maintain the construction schedule, diesel impact pile driving within the Fraser River is expected to continue until spring 2023 during the following allowable work hours:

- Monday to Friday between 7 a.m. and 7 p.m.
- Saturdays between 9 a.m. and 5 p.m.

Please note, river conditions and flow rates may impact the work schedule. All work will comply with City of Delta and Vancouver Fraser Port Authority bylaws and permit variances.


Construction activities that will not have a significant impact on surrounding communities will continue 24 hours a day, seven days a week, as needed, until spring 2023. Anticipated activities will include:

- Dredging
- Pipe placement
- Concrete pours
- Welding
- Vibratory sheet extraction
- Equipment maintenance

Noise Impacts & Our Commitment to You

Metro Vancouver is committed to minimizing the impacts of this work on the surrounding community. To meet that commitment, crews will use a quieter vibratory hammer to complete the majority of the in-river pile driving work. Heavier impact hammer equipment will only be used as needed during the allowable daytime hours.
